### **ORDER:**

The University has granted Provisional Affiliation to conduct the M.S. (Ophthalmology) & D.O. in Post Graduate Degree/Diploma Courses at **Aravind Eye Hospitals & Postgraduate Institute of Ophthalmology, No.1, Anna Nagar, Madurai - 625 020**. The said course had been initially started and affiliated under the ambit of Madurai Kamaraj University, Madurai.

2. In the reference first, to fourth cited, the University has granted the Continuance of Provisional Affiliation order to **Aravind Eye Hospitals & Postgraduate Institute of Ophthalmology, Madurai** for conducting the Degree/Diploma Courses M.S. (Ophthalmology 12 seats) & Diploma in Ophthalmology 08 seats. The sanctioned intake was recognised by Medical Council of India, New Delhi.

3. In pursuance to Board of Governors in Supersession of Medical Council of India, New Delhi, on **28.02.2019**, has permitted to convert Post Graduate Diploma seats into corresponding PG degree seats is subject to affiliation of additional PG degree seats by the concerned University.

4. Based on the above, the Tamil Nadu Dr. M.G.R. Medical University grants **Continuance of Provisional Affiliation to enhancement the seats in PG degree (from 12 to 20 seats) by surrendering the corresponding PG Diploma 08 seats for the academic year 2019-2020 to Aravind Eye Hospitals & Postgraduate Institute of Ophthalmology, Madurai**, as indicated below, subject to the usual conditions already communicated in the Provisional Affiliation order of this University.
